

# About Elementary and Secondary School Emergency Relief Funds (ESSER)

Congress set aside approximately \$13.2 billion of the \$30.75 billion allotted to the Education Stabilization Fund through the Coronavirus Aid Relief, and Economic Security (CARES) Act for the Elementary and Secondary School Emergency Relief Fund (ESSER Fund). Signed into law on March 27, 2020, the Department awarded these grants to State educational agencies (SEAs) for the purpose of providing local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that COVID-19 has had, and continues to have, on elementary and secondary schools across the Nation.

By analyzing the ways LEAs have used the first 2 rounds of ESSER funding, we seek to highlight areas of opportunity for ESSER ARP investment.

# Goals of ESSER Funding

To address the impact that COVID-19 has had, and continues to have, on elementary and secondary schools across the Nation.

Any expense could potentially be eligible, but funds focus on:

- Helping schools safely reopen,
  - (e.g. enhanced cleaning, sanitation supplies, etc.)
- Sustaining the safe operation of schools, and
  - (e.g. social distancing furnishings, improved air circulation, expanded/outdoor learning spaces etc.)
- Addressing the impact of the coronavirus pandemic on the Nation's students.
  - (e.g. extended day/year programming, 1:1 tutoring, counseling, etc.)



## **ESSER FUNDING GROUPS**

**ESSER (CARES)** 

March 27, 2020

- Aimed at preventing, preparing for, and responding to COVID-19.
- ESSER funds may be used for the same allowable purposes as ESSER II and ARP ESSER, including hiring new staff and avoiding layoffs.



**ESSER II (CRRSA)** 

**>>>** 

January 5, 2021

An LEA should use funds for:

- · addressing learning loss,
- preparing schools for reopening, and
- testing, repairing, and upgrading projects to improve air quality in school buildings
- ESSER II funds may be used for the same allowable purposes as ESSER and ARP ESSER, including hiring new staff and avoiding layoffs.



March 11, 2021

An LEA must spend 20% of its total ARP ESSER allocation to

- address learning loss through the implementation of evidence-based interventions, such as:
  - summer learning or summer enrichment.
  - extended day,
  - comprehensive afterschool programs, or
  - extended school year programs, and
- ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of COVID-19 on underrepresented student subgroups.



# **Funding Formulas**

State Education Authority (SEA) allocations are in the same proportion as Part A of Title I of the ESEA of 1965, as amended, in fiscal year 2019.

- SEA may retain 10% for administrative overhead.
- The remaining funds are required to be distributed to LEAs in proportion to the Part A of Title I of the ESEA of 1965, as amended, in fiscal year:
  - 2019 for ESSER (CARES)
  - 2020 for ESSER II (CRRSA)
  - 2020 for ESSER ARP

### Example:


ESSER (CARES) has a total of **\$13,229,265,000** in funding.

Mississippi receives **1.28%** of all Part I of Title I funds in 2019

\$13,229,265,000 x 1.28% = **\$169,883,002** in funding for MS SEA

MS SEA reserves 10% or **\$16,988,300** for Administration \$169,883,002 - \$16,988,300 = **\$152,894,702** in funding for disbursement to LEAs

Greenwood-LeFlore receives **2.26**% of all MS Part I of Title I funds in 2019 \$152,894,702 x 2.26% = **\$3,455,420** in funding for Greenwood-LeFlore LEA




### ESSER II (CRRSA)

- Enacted 12/27/2020
- Eligible Expense Dates: 3/13/2020 -9/30/2022

### ESSER (ARP)

- · Enacted 3/11/2021
- Eligible Expense Dates: 3/13/2020 -9/30/2023







# Eligible Uses



Any activity authorized by the ESEA, the Individuals with Disabilities Education Act (IDEA), the Adult Education and Family Literacy Act (AEFLA), or the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins).



Coordination of LEA preparedness and response efforts with state, local, tribal, and territorial public health departments, and other relevant agencies, to improve coordinated responses with other agencies to prevent, prepare for, and respond to coronavirus.



Activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth, including how outreach and service delivery will meet the needs of each population.



Developing and implementing procedures and systems to improve the preparedness and response efforts of LEAs.



Training and professional development for LEA staff on sanitation and minimizing the spread of infectious diseases.

# Eligible Uses (cont.)



Purchasing supplies to sanitize and clean the facilities of an LEA, including buildings operated by such agency.



Planning for, coordinating, and implementing activities during long-term closures, including how to provide meals, technology for online learning, guidance on IDEA requirements, and ensuring other educational services can continue to be provided consistent with all applicable requirements.



Purchasing educational technology (including hardware, software, and connectivity) for students served by the LEA that aids in regular and substantive educational interactions between students and their classroom teachers, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment.



Providing mental health services and supports, including through the implementation of evidence-based full-service community schools.



Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children in foster care.

# Eligible Uses (cont.)



Addressing learning loss among students, including low-income students, students with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and children in foster care, of the local educational agency, including by-



Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic progress and assist educators in meeting students' academic needs, including through differentiating instruction.



Implementing evidence-based activities to meet the comprehensive needs of students.



Providing information and assistance to parents and families on how they can effectively support students, including in a distance learning environment.



Tracking student attendance and improving student engagement in distance education.

# Eligible Uses (cont.)



School facility repairs and improvements to reduce risk of virus transmission and exposure to environmental health hazards, and to support student health needs.



Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and non-mechanical heating, ventilation, and air conditioning systems, filtering, purification, and other air cleaning, fans, control systems, and window and door repair and replacement.



Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff.



Other activities that are necessary to maintain operations and continuity of services and continuing to employ existing staff.



# **ONE-TIME Funds**

Unlike conventional Title 1 funding on which the funding formula is based, ESSER funds are one-time funds

- Use of non-recurring funding is <u>not</u> recommended for:
  - Additional staffing,
  - Long term programs, or
  - Regular Operating Costs (e.g. utility bills, food services, transportation).
- Generally Advisable uses
  - Immediate needs for consumables like masks, sanitation, etc.
  - Investment
    - Physical Plant,
    - Long-term use curriculum development, or
    - Durable or immoveable goods.
  - Temporary programs used for a finite duration,
  - Teacher training, or
  - Virtual Learning Technology and infrastructure.

Subject: Changes to Federal Purchasing Rules


On June 20, 2018, The Office of Management and Budget (OMB) released a Memorandum regarding "Implementing Statutory Changes to the Micro-Purchase and the Simplified Acquisition Thresholds for Financial Assistance". The implementation of this guidance allows maximum flexibility in granting an exception in allowing grantees to use a higher threshold for micro purchase. However, grantees also must adhere to state and local procurement standards to the extent those standards are more restrictive than federal requirements. (2 CFR § 200.318(b)). This memo will supersede the guidance issued from the MDE on June 22, 2017.

Accordingly, consistent with federal and Mississippi standards, grantees using federal funds to make purchases of goods (commodities) under \$5,000 and services under \$10,000 are "micro purchases". The purchase orders for micro purchases may be awarded without soliciting any competitive quotes if the costs are deemed reasonable. To the extent practicable, these purchases should be distributed equitably among qualified suppliers.

All federal purchases of goods (commodities) between \$5,001 to \$50,000 and services between \$10,001 to \$250,000 must have two (2) price quotes from qualified sources.

Any purchase of goods (commodities) above \$50,000 must adhere to House Bill 1109, passed during the 2017 Mississippi Legislative Session. There are exceptions to the bill that include state contract and Express Products List (EPL) purchases. Any services over \$250,000 will need to follow the competitive bidding process outlined in the Uniform Administrative Requirement (2 CFR § 200.320(c)-(d)).

Please ensure that you make the necessary changes to your board policies, procedures and practices to ensure compliance with federal and state audits.



# Local Procurement Capacity

- Most districts are expanding funding for Federal Grant Management Staffing
- Individual LEAs will need to properly scope and bid construction projects to ensure funding eligibility
- Coordination of physical plant alterations is critical to district-wide serviceability
- Funding timeline may constrain available contracting resources in regions
- Project Management and construction timelines may pose threats to funding draw downs
- Unique nature of major investment on this scale may exceed encumbrance and payment processing capacity of LEAs





### Mississippi 2021 ESSER (CRRSA) Spending by Expenditure Codes





### Emergency response, planning, and interagency communication


